## **Position purpose**

This is a Fixed-Term, Part-Time up to (0.6 EFT) 3 days / week.

### **Role Purpose:**

- Assess spinal presentations referred to Neurosurgery / Orthopaedic Surgery and triaged for the Advanced Physiotherapy Practice (APP) pathways in these clinic
- Collaborate with the Neurosurgery / Orthopaedic Surgery team to arrange investigations and assist clinical decision making in the management of spinal presentations
- Communicate assessment findings and recommended management plan to referring doctors and colleagues within the Orthopaedic / Neurosurgery clinical specialties
- Assess and treat patients referred to the Physiotherapy Outpatients Department

## About the Directorate/Division/Department

The Physiotherapy Department comprises approximately 112 EFT staff at the Austin Hospital, Heidelberg Repatriation Hospital and the Royal Talbot Rehabilitation Centre. Clinical A physiotherapy clinical service is provided seven days per week, 12 hours per day to acute and aged care inpatient areas as well as outpatient and community services. There is a seven-day primary care service for musculoskeletal injuries in the Emergency Department.

The Physiotherapy Outpatients service provides care at the Health and Rehabilitation Centre (HRC), this includes individual assessment / treatment and a variety of evidence-based group treatment sessions in both our gym and aquatic treatment areas. The service has strong partnerships across Orthopaedics, Neurosurgery and the Emergency Department at Austin Health, including several imbedded Advanced Physiotherapy Practice positions.

Both Austin Neurosurgery and the Department of Orthopaedic Surgery have dedicated Spinal Surgery teams that manages a wide variety of spinal presentations including trauma, radiculopathy and complex spinal cases. The head of the Orthopaedic Spine Surgery Unit is Mr Gerald Quan, an Australian and International Fellowship-trained consultant orthopaedic surgeon specializing exclusively in spinal surgery. Mr Gus Gonzalvo is the current directly of Neurosurgery.

## Position responsibilities

#### **Role Accountabilities:**

#### **Patient Care**

- Appropriately assess patients streamed to the APP pathway of both the Neurosurgery (Radiculopathy) and Orthopaedic Spine Outpatient Clinics
- Appropriately identify, document and evaluate assessment findings, management plans, patient goals and clinic outcomes within the relevant APP spine clinics
- Communicate assessment findings, management plans and patient outcomes with referring doctors and other health professionals involved in the patients care
- Facilitate timely access to either Neurosurgery or Orthopaedic Consultants when surgical consideration may be indicated
- Ensure all clinical risks and complications are identified and reviewed directly with either the Neurosurgery or Orthopaedic Surgery Medical Team
- Support and direct patients assessed as not requiring surgery to suitable, evidence-based spinal pain interventions
- Remain current with assessment and management options relevant to Neurosurgery /Orthopaedic spinal presentations at Austin Health
- Act as a clinical resource for health professionals working within both the Neurosurgery and Orthopaedic Spine Clinic
- Provide high quality, patient centred, evidence based clinical care to Physiotherapy Outpatients
- Model best-practice, advanced musculoskeletal physiotherapy in the provision of outpatient care
- Undertake comprehensive physiotherapy assessment and consultation regarding complex clinical care relevant to Outpatient Physiotherapy
- Act as a clinical resource for Physiotherapists / Physiotherapy students (on placement) in the Physiotherapy Outpatients Department

### **Credentialing and Scope of Clinical Practice**

 Work with senior spinal clinic APPs in Neurosurgery and Orthopaedic spine to complete APP credentialling

## Selection criteria

#### Essential skills and experience:

- Physiotherapist currently registered for practice in Australia (AHPRA)
- Post Graduate Masters in Musculoskeletal Physiotherapy (or equivalent)
- Significant musculoskeletal physiotherapy experience in the assessment and management of spinal conditions in an outpatient setting
- Excellent communication, organisation and problem-solving skills
- Commitment to physiotherapy professional development musculoskeletal / spinal pain
- Sound understanding of information technology including clinical systems and applications

#### Desirable but not essential:

- Previous experience in an Advanced Practice Physiotherapy Position
- Exposure / experience in an Advanced Practice Physiotherapy Position (Spinal Pain)

- Current physiotherapy registration in Australia with AHPRA
- Post Graduate Masters in Musculoskeletal Physiotherapy (or equivalent)
