### Position purpose

The Cardiology Department is responsible for the provision of an extensive range of cardiac services to inpatients and outpatients including general cardiology, heart failure, pulmonary hypertension, echocardiography, cardiac catheterization, interventional and structural procedures and non-invasive diagnostic procedures.

This role provides heart failure patient assessment, consultation and management for inpatients and outpatients across Austin Health. It offers Telehealth advice and support to nurse practitioners, general practitioners and community nurses with the overall aim of managing heart failure patients at home rather than hospital where appropriate.

### About the cardiology department

The Department of Cardiology is located on Level 5 at the Austin Hospital Campus. Clinical and administrative activities occur on Level 5 at the Austin Tower and Harold Stokes Building.

Medical staff comprises cardiologists, RACP accredited advanced trainee cardiology registrars, HMOs, sub-specialty fellows encompassing non-invasive imaging, pulmonary hypertension, heart failure, structural cardiology, interventional cardiology and electrophysiology, and a number of higher degree research fellows.

The Cardiology department provides an extensive range of cardiac services to inpatients and outpatients. These services include consultations, echocardiography, non-invasive testing (ECG, Holter monitoring), coronary angiography and percutaneous intervention for coronary and non-coronary applications (congenital and valvular), electrophysiological testing and ablation (including AF ablation) and device implantation (pacemaker, ICD and CRT). The department provides 24-hour cardiac catheterisation laboratory services for acute myocardial infarction. In-patients are managed predominantly in the 30-bed Cardiac and Thoracic Unit on Ward 5 East. The department has links to the University of Melbourne and a major involvement in teaching, training and research at undergraduate and post-graduate levels, for both nursing and medical staff.

## Position responsibilities

### Role Specific:

#### Clinical Care

- Provide heart failure patient assessment, consultation and management for inpatients and outpatients across Austin Health.
- Develop competence in point-of-care ultrasound (POCUS).
- Understand and apply the indications for device therapy in heart failure (pacemakers and ICDs).
- Review and participate in the management of patients with cardiogenic shock.
- Understand the role of intra-aortic balloon pumps and mechanical circulatory supports (ECMO, Impella).
- Assist in invasive diagnostic procedures including right heart studies and endomyocardial biopsies.
- Participate in multidisciplinary meetings and educational forums focused on cardiogenetics and advanced heart failure therapies.
- Facilitate consultations relating to genetic testing and results disclosure for patients with complex cardiomyopathies.
- Participate in the diagnosis and longitudinal management of patients with acquired and inherited cardiomyopathies, including sarcoidosis, amyloidosis, hypertrophic cardiomyopathy and arrhythmogenic right ventricular cardiomyopathy.
- Telehealth advice and support to Austin Health nurse practitioners, general practitioners and community nurses with the overall aim of managing heart failure patients at home, rather than hospital (where appropriate).
- Participate in cardiology unit clinical meetings and educational activities including research projects in heart failure.
- Demonstrate a commitment to working as a team member with medical peers, residents, nursing and other staff to provide efficient, safe and quality care across the continuum.
- Participate in the auditing and review of clinical practices to improve clinical outcomes as part of Clinical Governance Systems within the Heart Failure Service.

## Selection criteria

### Essential skills and experience:

- Must be a registered Medical Practitioner in Australia with the Australian Health Practitioner Regulation Agency (AHPRA) - (note eligible applicants will be assisted through this process).
- Have appropriate training and experience applicable to the field of cardiology.
- The ability and commitment to work as a team member with senior medical, resident, nursing and other staff.
- A commitment to quality, excellence and best practice in the delivery of cardiac services to Austin Health's patients (including inpatient services, outpatient services, diagnostic and interventional services as appropriate).
- An understanding of the role of clinical audit and quality review in the process of patient service improvement.
- Demonstrates multidisciplinary engagement, teamwork and collaboration.
- Have demonstrated ability to communicate effectively at all levels.

### Desirable but not essential:

- A sound understanding of information technology including clinical systems and applications.
- An understanding of the complexities and challenges of public health.

## Professional qualifications and registration requirements

- Registered Medical Practitioner in Australia, preferably with postgraduate qualifications in an area relevant to Cardiology.
- Candidates must have completed core cardiology training of the RACP or overseas equivalent.
