Position purpose

- To train fellows to a level of proficiency in interventional cardiology that they may return to their place of origin and assume work as independent practitioners.
- To ensure that fellows are current in their understanding of recent advances in the field, particularly advances which apply to daily practice.
- To understand and participate in the clinical audit process including outcomes in interventional cardiology.
- To participate and run a clinical research project within the department, aiming for a first author publication in a peer-reviewed medical journal, and to assist other fellows with projects as appropriate.

About the cardiology department

The Department of Cardiology is located on Level 5 at the Austin Hospital Campus. Clinical and administrative activities occur on Level 5 at the Austin Tower and Harold Stokes Building.

Medical staff comprises cardiologists, RACP accredited advanced trainee cardiology registrars, HMOs, sub-specialty fellows encompassing non-invasive imaging, pulmonary hypertension, heart failure, structural cardiology, interventional cardiology and electrophysiology, and a number of higher degree research fellows.

The Cardiology department provides an extensive range of cardiac services to inpatients and outpatients. These services include consultations, echocardiography, non-invasive testing (ECG, Holter monitoring), coronary angiography and percutaneous intervention for coronary and non-coronary applications (congenital and valvular), electrophysiological testing and ablation (including AF ablation) and device implantation (pacemaker, ICD and CRT). The department provides 24-hour cardiac catheterisation laboratory services for acute myocardial infarction. In-patients are managed predominantly in the 30-bed Cardiac and Thoracic Unit on Ward 5 East. The department has links to the University of Melbourne and a major involvement in teaching, training and research at undergraduate and post-graduate levels, for both nursing and medical staff.

Position responsibilities

Role Specific:

Fellows must be familiar with and able to participate in pre- and post-procedural management of patients undergoing elective cardiac catheterisation and interventional procedures in Ward 5N, and also of those requiring inpatient procedures, originating in the Ward 5E (Cardiac), Intensive Care Unit, Emergency Department and outlying wards on the Austin Campus.

Clinical duties of particular importance include:

- Explanation of procedures to patients and obtaining informed consent.
- Accurate prescription of pre and post-procedural medications.
- Perform critical technical manipulations of the case under consultant supervision.
- Post procedural vascular access site care and management of comorbid conditions.
- Generate accurate written procedural reports in a timely manner.
- Rapid and accurate assessment and management of patients with haemodynamic, haemorrhagic and ischaemic complications of diagnostic and interventional procedures.
- Clinical follow-up of patients in the post-procedural phase.
- Entry of clinical details and quantitative angiographic parameters into relevant databases including MIG and VCOR.
- Assist in recruiting suitable patients into research trials.
- Organisation of the interventional cardiology departmental meetings including presentation of topics and audits.
- Participate in the formulation of local guideline and update of protocols as required.

Fellows are required to participate in and achieve competence in the following procedures, initially as assistants and then as supervised first operators:

- Diagnostic coronary angiography (at least 150 cases/year).
- Diagnostic right and left heart catheterisation (at least 25 cases/year).
- Elective and emergent coronary angioplasty and stenting (at least 200 cases/year).

- Insertion of intra aortic balloon pumps (at least 5 cases during fellowship).

Fellows may be required to assist with percutaneous closure of congenital defects, aortic and mitral valvuloplasty, transcatheter aortic valve replacement, other structural heart procedures, and peripheral vascular interventional procedures, but are not expected to achieve independent operator status.

Selection criteria

Essential skills and experience:

- Must be a registered Medical Practitioner in Australia with the Australian Health Practitioner Regulation Agency (AHPRA), preferably with postgraduate qualifications in an area relevant to Cardiology.
- Candidates must have completed core cardiology training of the RACP or overseas equivalent.
- A high standard of clinical care and a proven track record in clinical research.
- The ability and commitment to work as a team member with senior medical, resident, nursing and other staff.
- A commitment to quality, excellence and best practice in the delivery of cardiac services to Austin Health's patients (including inpatient services, outpatient services, diagnostic and interventional services).
- An understanding of the role of clinical audit and quality review in the process of patient service improvement.
- Demonstrates multidisciplinary engagement, teamwork and collaboration.
- Have demonstrated ability to communicate effectively at all levels.

Desirable but not essential:

- A sound understanding of information technology including clinical systems and applications.
- An understanding of the complexities and challenges of public health.

Professional qualifications and registration requirements

- Registered Medical Practitioner in Australia, preferably with postgraduate qualifications in an area relevant to Cardiology.
- Candidates must have completed core cardiology training of the RACP or overseas equivalent.
