# Position purpose

The role aims to provide art therapy interventions for patients and families from a patient-centered interdisciplinary model. This is informed by the Austin Health framework that uses a patient-centred approach and has a professional ethos based on a strong culture of evidence-based practice, robust clinical governance and personal accountability for quality improvement and life-long continuing professional development.

The role is clinically/patient facing, providing both individual and group interventions, and will include a focus on clinical student supervision or other tasks as directed by the management.

#### About the Directorate/Division/Department

### **Medical and Cancer Service Division**

Austin Health is one of the largest cancer service providers in Victoria. A complete range of services are delivered to patients and their families, including medical oncology, clinical haematology,

radiation oncology (Austin Health and BHS), cancer genetics, palliative care, wellness and supportive care programs, an active volunteer program and specialist cancer surgery (managed via a separate CSU). These are all provided in an environment that integrates research, teaching, and training.

All Austin Health metropolitan-based Cancer Services are now delivered within the Olivia Newton-John Cancer & Wellness (ONJ Centre) at the Austin Hospital. This state-of-the-art facility provides a new model of individualised cancer care for patients and their families.

Clinical Services are provided in a range of inpatient and ambulatory settings. Inpatient services include an acute oncology/clinical haematology ward, an oncology/surgical oncology ward and a palliative care ward. Ambulatory services include Radiation Oncology, Day Oncology, Apheresis, and multidisciplinary cancer clinics.

#### Wellness and Supportive Care

The integrated model of multidisciplinary care within Cancer Services relies on a dynamic, appropriately qualified, and skilled team to support patients undergoing care in both the Inpatient and Ambulatory settings, with a key focus on Integrated Wellness and Supportive Care.

# Position responsibilities

The Grade 2 Art Therapist will work as part of the Wellness and Supportive Care Program as well as within the broader multidisciplinary team context. The Grade 2 Art Therapist will need to demonstrate sound experience in planning and delivering appropriate evidence-based art therapy interventions to patients and carers in oncology settings. Clinical work will include mainly outpatients providing both individualised and group art therapy.

### The position involves:

- Being part of multi-disciplinary teams, liaison work, attending relevant team meetings/s
- Plan and deliver tailored, high quality, evidence-based Art therapy services to cancer patients and their careers, individually and within groups, and in collaboration with the Arts in Healthcare team.
- Actively participate and co-facilitate clinical placement student supervision
- Actively participate in weekly team meetings to raise the profile of the Arts Therapy program and generate referrals to all services.
- Accepts responsibility for professional self-development through review of own performance and identification of learning opportunities
- Make referrals to all other health disciplines as required.
- Co-facilitating programs where appropriate
- Maintain some involvement in policy and planning activities.
- Contribute to Quality Improvement projects.
- Engage in the evaluation of programs and service provision.
- Develop a yearly exhibition program for the ONJ Centre's exhibition space that is sensitive to cultural concerns of the ONJ Centre & consumer experience.

- Excellent communication and interpersonal skills relevant to service delivery and the ability to build rapport with clients & other health professionals.
- Demonstrated knowledge of contemporary methods principles and practice and skills across the relevant profession.

- Experience in managing art collections (records management, display & conservation of artworks; acquisition & commission of new art works).
- A sound understanding of information technology including clinical systems.
- Experience in art therapy in an oncology setting
