Position purpose

Working under the direction of senior Radiation Therapists, the Grade 2 RT is responsible for the safe delivery of radiotherapy planning and treatment according to all department protocols, policies and standards. The Grade 2 RT is required to work both in a team and independently and be self-motivated in applying their technical expertise and experience within their work area. The Grade 2 RT will strive to maintain effective communication with all clients and care for the needs of these clients as they undergo the planning and treatment process. They will act as a role model and play an active role in the mentoring and development of learners.

The Grade 2 RT maintains and updates skills through active participation in project groups and professional development. The Grade 2 RT is a vital part of a multidisciplinary team and is expected to participate in all care activities.

The Grade 2 RT will possess additional skills and responsibilities, above and beyond the Grade 1 classification. Examples of areas of specialised skill, expertise and responsibility may include:

- Brachytherapy
- Education
- IT systems relating to RT
- Stereotactic RT

Austin Health Radiation Oncology at the Olivia Newton-John Cancer Wellness & Research Centre (ONJ Centre) is committed to providing a service that embraces new technology, new techniques and new ways of treating each patient so that the best outcome can be achieved. The ONJ Centre and the Ballarat Austin Radiation Oncology Centre (BAROC) partner to provide radiotherapy services across the northeastern Melbourne and Grampians regions with a holistic approach to cancer and supportive care. Austin Health also provide remote consultations and a superficial skin treatment service at the newly opened Stawell Austin Radiation Oncology Service (SAROS). The ONJ Centre has state of the art equipment and facilities including Siemens CT Simulator with Vision RT 4DCT, 3 Elekta Linacs (2 x Versa HD), 6 DOF couches, ABC breath hold, Body Fix stabilisation and Brainlab Exactrac imaging. Mosaiq is used for the record and verify medical record and programs such as MIM Maestro and Mobius FX & 3D to support our work. The Gynaecological brachytherapy service is supported by a Flexitron HDR treatment unit and Oncentra planning with MRI simulation. Superficial XRay Treatment is provided with a WoMED superficial machine. ONJ Centre leads the Victorian MRI Program which is supported by the Elekta Unity MR Linac and 1.5T Philips Ingenia Ambition MRI for RT Simulation supporting a full MRI workflow for radiotherapy patients.

We're a team of technologically driven health professionals encompassing radiation oncologists, radiation therapists, radiation oncology medical physicists underpinned by allied health, nursing and administrative support services to ensure we deliver the best care available; efficiently and focused on the needs of each individual patient. Our team constantly working with referrers, researchers and consumers to improve patient outcomes through evidence-based processes and new and innovative technologies.
