#### **Position purpose**

This position is working with the Clinical Haematology Department at Austin Health. The Data Entry Officer will assist the Clinical Haematology Clinicians with the maintenance and population of several registries and databases that contribute to internal clinical operations, clinical research, and national and international quality assurance programs. This position offers an opportunity to engage closely with a friendly and supportive team of clinicians, including direct supervision with, and mentorship from, senior medical staff.

# **About the Clinical Haematology Department**

The Clinical Haematology Unit located in the ONJ Centre provides a range of inpatient (28 bed Haematology Ward), day patient (Day Oncology) and outpatient services for a range of benign and malignant haematological conditions including autografting and allografting, with close links with Laboratory Haematology.

The allogeneic service, one of only 3 adult services in Victoria, continues to expand including provision of transplants from haploidentical (half-matched) donors as well as being a referral centre

for donor evaluation on behalf of the Australian Bone Marrow Donor registry (ABMDR). Austin Health remains the main referral centre for donor stem cell collection (apheresis) for the northeastern region of metropolitan Melbourne and has strong affiliations with regional centres.

The Unit has access to a comprehensive apheresis service and focuses on individualised care for both the patient and family including late-effects and survivorship. A consultative service is provided throughout Austin Health as well as to other health services in the northeast and regional areas. There is an active clinical haematology research and clinical trial program, and research collaborations with the Olivia Newton John Cancer Research Institute (ONJCRI).

# Position responsibilities

## **Role Specific:**

This role will complete data entry requirements of the Clinical Haematology Department including but not limited to:

- Data entry requirements for unit clinical operational activities
- Patient databases related to clinical audit and quality assurance
- Patient registries as part of established clinical and/or research programs
- Other general administrative duties as required

The delegation of each data entry task will be logged. Appropriate training, supervision and feedback opportunities will be provided by clinical staff for each task.

- Ability to function well within a team
