## **Position responsibilities**

The Medical Librarian is a customer service focussed role, assisting with the day-to-day activities of the Library.

- Attend to email, front desk, telephone and online queries.
- Undertake document delivery and interlibrary loan services, ensuring adherence to copyright legislation.
- Assist with collection management and accounts payable administration.
- Contribute to Library training events and orientations.
- Participate in various Library and wider organisational activities, and assume other responsibilities as assigned.

This is a six-month role.

- Eligibility for professional membership of the Australian Library & Information Association, or considerable progress towards achieving this.
- Demonstrated commitment to delivering high-quality customer service.
- Proficiency in digital tools such as library management software, clinical information databases, Microsoft Office, and/or artificial intelligence tools.
- Strong interpersonal skills, with a proven ability to manage and build strong relationships with diverse stakeholders, and to work collaboratively as part of a specialist team.

- Experience using GratisNet or other document delivery systems.
- Prior experience working in a health library setting.
