Position purpose

The primary purpose will be to provide timely, safe, and effective clinical care to orthopaedic and musculoskeletal patients through our Physiotherapy inpatient/outpatient programs.

This appointment will also support the Physiotherapy service to provide:

- Student supervision/education for University of Melbourne DPT (Musculoskeletal) placements and other university partners (as required)
- Clinical support, training and education to junior/rotating physiotherapists within a Musculoskeletal / Orthopaedic clinical setting
- Contribution physiotherapy department quality initiatives and the strategic direction for Physiotherapy at Austin Health

About the Physiotherapy Department

The Physiotherapy Department comprises about 112 EFT staff at the Austin Hospital, Heidelberg Repatriation Hospital and the Royal Talbot Rehabilitation Centre. It provides seven days per week, 12 hours per day services to acute and aged care areas. There is also a seven day a week primary care service for soft tissue injuries in the Emergency Department

Our department is focused on providing high quality evidence-based care to all patients and clinical research is a priority of the department. It is a major clinical school for the University of Melbourne with responsibility for about 180 students from 1st through to 3rd year for the Doctorate of Physiotherapy (DPT) course. In addition, the department is also a major clinical school for Swinburne University.

The Grade 2 Physiotherapist employed into this position will work in a rotational capacity, consisting of 6-month rotations across the acute and subacute rehabilitation streams on all three Austin Health campuses.

- Appropriately triage, assess, and treat musculoskeletal / orthopaedic patients
- Clearly document musculoskeletal / orthopaedic patient management
- To provide consultation and work collaboratively with all health professionals and/or institutions regarding musculoskeletal / orthopaedic assessment findings, outcomes, and management plans
- Contribute to the daily prioritisation and allocation of clinical workloads
- Facilitate safe and effective discharge planning and follow-up service when required
- Remain current with evidence-based treatment options / techniques and procedures relevant to Musculoskeletal / orthopaedic patients
- Ensure musculoskeletal / orthopaedic patients have appropriate knowledge and understanding of the expectations of proposed physiotherapy interventions
- Evaluate and identify musculoskeletal / orthopaedic patient goals, outcomes and expected level of function to facilitate timely and appropriate care
- Monitor musculoskeletal / orthopaedic patient experience, achieving high levels of patient satisfaction and clinical outcomes
- Promote the use of evidence-based outcome measures within musculoskeletal / orthopaedic patient populations
- Act as a clinical resource for health professionals working with musculoskeletal / orthopaedic patients
- Work across a mixed caseload in the community setting as required, appropriately able to assess and treat a wide variety of clinical presentations.
