Ensure use of lifting devices or appropriate equipment available in the department to reduce risk of manual handling.

Communicate well with staff to co-ordinate and priorities processing of equipment to enable the provision of optimal patient care.

Being able to reprioritize activities in response to sudden changes in their work environment.

Demonstrate the ability to function well as a team member.

Should be aware of management protocols following exposure to blood and body fluids.

Be familiar with Policy related to reporting staff injuries.

Attending staff development programs and in-service education sessions.

Participate in continuous quality improvement activities relevant to sterilizing department.
