# Position purpose

The Pathology Logistics Manager is responsible for coordinating and managing the logistical operations within the Austin Health Pathology network. This includes overseeing the timely and accurate transportation of specimens, supplies, and information to support the laboratory's diagnostic processes. The role requires strong organizational skills, attention to detail, and effective communication with internal teams and external partners.

# About the Directorate/Division/Department

Austin Health Pathology is a department of Austin Health and provides service to not only Austin Health and the co-located Mercy Hospital for Women, but also to numerous GPs and Specialists in the metropolitan and regional community. Austin Health Pathology is currently expanding into the Hume, Loddon Mallee and Goulburn Valley areas of regional Victoria, with laboratories in Shepparton,

Mildura, Echuca and Swan Hill, and a point-ofcare network including Castlemaine, Kerang, Kyneton, Seymour, Cohuna and Kyabram. Austin Health Pathology is committed to providing high quality patient care through routine and complex diagnostic services, expert advice and support for teaching and research.

Austin Health Pathology is an accredited laboratory with the National Association of Testing Authorities Australia (NATA), the Royal College of Pathologists of Australia (RCPA), National Safety and Quality Health Services Standards (NSQHS), National Pathology Accreditation Advisory Council and Medicare Australia, supported by a network of Collection Centres at hospital sites and within the community.

The Department is managed by a Pathology Executive. This group is committed to providing comprehensive laboratory testing in a manner consistent with the needs of a university teaching hospital and the strategic directions of Austin Health.

Austin Health Pathology seeks to maintain its position at the cutting edge of Pathology analytical and clinical services. The Department constantly reviews and updates testing methodologies, instrumentation, and work practices, as well as monitoring result turnaround times and other key performance indicators.

# Position responsibilities

#### **Role Specific:**

#### General:

- Identify opportunities for process optimization, efficiency enhancement, and cost reduction within the logistics workflow.
- Implement best practices and innovative solutions to enhance the overall logistics function.
- Identify and manage continuous improvement projects.
- Implement and adhere to regulatory guidelines and quality standards relevant to specimen transportation and laboratory operations.
- Resolve any arising problems or complaints and escalate issues as required.
- Undertake other tasks or responsibilities as agreed with the General Manager (Operations)
- Work closely with the relevant internal stakeholders to ensure seamless coordination of operations.

#### **Couriers:**

- Assess and recommend ideal transport methods, routing or carriers to meet necessary parameters, specifications and costs.
- Recruit, train, and manage a team of couriers responsible for specimen and material transportation.
- Provide guidance and support to couriers while promoting a culture of safety and professionalism.
- Plan efficient routes to minimize transportation time and costs while adhering to safety and regulatory standards.
- Monitor and track courier activities to ensure compliance with transportation protocols.
- Work with relevant departments to facilitate the ongoing management and maintenance of the vehicle fleet.
- Implement and maintain procedures to handle different types of specimens, including hazardous materials, in compliance with safety protocols.
- Oversee the proper packaging, labeling, and handling of specimens to maintain sample integrity during transportation.









- Collaborate with laboratory and healthcare staff to address any issues related to specimen quality or transportation deviations.
- Maintain accurate records of specimen transportation, including pickup and delivery times, locations, and any discrepancies.
- Generate regular reports for management, highlighting transportation efficiency, compliance, and any incidents.
- Collaborate with external vendors, courier services, and partners to facilitate efficient sample transportation.

# Supply:

- Collaborate with procurement teams to ensure timely replenishment of supplies to avoid disruptions.
- Collaborate with vendors, negotiate contracts, and evaluate supplier performance.
- Implement and maintain processes for efficient order placement and tracking.
- Develop and implement inventory management strategies to optimize stock levels while minimizing wastage.
- Utilize inventory management software and tools to track and manage stock.
- Collaborate with pathology staff to identify and address any quality issues related to supplies or reagents.
- Recruit, train and manage a team responsible for the distribution of supplies.
- Plan and coordinate the distribution of supplies and materials to different departments or locations. This includes entry into the Austin Health procurement software as well as picking, packing and delivering to requestors location.
- Allocate supplies appropriately to different projects or processes, considering priority and demand.
- Monitor vendor performance, resolve issues, and identify opportunities for collaboration and improvement.
- Work within budgetary constraints while ensuring an adequate supply of materials for laboratory operations.
- Identify cost-saving opportunities through bulk purchasing, negotiations, or alternative suppliers.
- Collect and analyze data related to supply usage, procurement costs, and inventory turnover.
- Generate regular reports for management, highlighting key metrics and trends
