## **Position Purpose**

The neuropsychology rater is responsible for conducting various psychometric measures, psychological assessments and clinical interview/ratings as specified in the protocols of clinical research undertaken by the Medical and Cognitive Research Unit.

## Medical and Cognitive Research Unit (MCRU)

**The Medical and Cognitive Research Unit** (MCRU) is located at the Heidelberg Repatriation Hospital Campus of Austin Health and is tiered within the Continuing Care Clinical Service Unit

under the Aged Care Services. It is the largest dementia clinical trials centre in the southern hemisphere, and one of the largest in the world.

MCRU has a strong and successful history in conducting numerous clinical trials in various neurodegenerative disorders, with a majority of the trials focusing on Alzheimer's Disease.

Recently refurbished, the atmosphere within MCRU is energetic, friendly, and cohesive, with strong teamwork ethic amongst all staff members. The unit comprises of study coordinators, medical investigators, administrative staff, a recruitment officer and neuropsychologist raters.

## Purpose and Accountabilities

#### Role Specific:

Clinical Research Rating Activities

- Administer, score and interpret neuropsychological evaluation and psychometric assessment in accordance with research protocol.
- Enter data pertaining to the neuropsychological evaluation and psychometric assessment as required.
- Liaise with study coordinators and other raters to ensure efficiency in administering various rating activities and overall clinic visit.
- Liaise with relevant external agencies in relation to the conduct and administration of neuropsychological evaluation and psychometric assessment, where relevant.
- Active participation in the planning, implementation and evaluation of patient care during their involvement in the research as a member of the multidisciplinary team.
- Maintain up-to-date and accurate data records and clinical notes.
- In conjunction with the unit manager, principal investigators and study coordinators, assist in the implementation of investigator led clinical research projects, including the preparation of research protocols and designs as well as data collection and analysis.

## Communication

- Maintain constant communication with the unit manager, medical investigators and study coordinators regarding rating related progress and activities.
- Attend research related meetings, and relevant unit and hospital-wide meetings.
- Maintain professional working relationship with staff members, and all internal and external stakeholders.

#### Education:

- Attend, participate and promote education programs (e.g., conferences, seminars and/or workshops) pertaining to clinical research and relevant fields to develop knowledge base and keep well-informed of current practices and issues in clinical research.
- Promote appropriate standards of professional psychology practice within the MCRU team through the participation in quality professional supervision, professional development, monitoring and quality improvement processes.
