Position purpose

Oncology Massage Therapy is an important service provided within the Wellness and Supportive Care Program. Working in collaboration with existing part-time Oncology Massage Therapists, this role will provide specialised oncology massage to selected patients with cancer both in the inpatient and outpatient setting. The role will collaborate with the multidisciplinary teams to support and care for patients throughout the cancer trajectory.

About the Directorate/Division/Department

Medical and Cancer Service Division

Austin Health is one of the largest cancer service providers in Victoria. A complete range of services are delivered to patients and their families, including medical oncology, clinical haematology, radiation oncology (Austin Health and BHS), cancer genetics, palliative care, wellness and supportive care programs, an active volunteer program and specialist cancer surgery (managed via a separate CSU). These are all provided in an environment that integrates research, teaching, and training.

All Austin Health metropolitan-based Cancer Services are now delivered within the Olivia Newton-John Cancer & Wellness (ONJ Centre) at the Austin Hospital. This state-of-the-art facility provides a new model of individualised cancer care for patients and their families.

Clinical Services are provided in a range of inpatient and ambulatory settings. Inpatient services include an acute oncology/clinical haematology ward, an oncology/surgical oncology ward and a palliative care ward. Ambulatory services include Radiation Oncology, Day Oncology, Apheresis, and multidisciplinary cancer clinics.

Wellness and Supportive Care

The integrated model of multidisciplinary care within Cancer Services relies on a dynamic, appropriately qualified, and skilled team to support patients undergoing care in both the Inpatient and Ambulatory settings, with a key focus on Integrated Wellness and Supportive Care.

Position responsibilities

Role Specific

Service delivery.

- Provision of oncology massage to cancer patients in both the inpatient and outpatient setting.
- Patient assessment, treatment, documentation in the medical record, liaison and communication with relevant clinical staff including medical, nursing, and allied health.
- Oncology massage delivered with sensitivity to the supportive care needs of patients and carers. This includes their psychological, emotional, spiritual, physical, and practical concerns.
- Making referrals to other members of the cancer care team as appropriate
- Causing minimal disruption to patients' medical treatment

Communication and teamwork

- Establish and promote effective relationships with members of the cancer services team including medical, nursing, and allied health staff.
- Promote respectful and constructive team relationships.
- Participate in and contribute to multidisciplinary team meetings as required.
- Participate in and contribute to multidisciplinary education as appropriate.

Documentation and data collection

- Ensure all contacts with patients are recorded and documented in the medical record.
- Ensure outcome measures are routinely used to evaluate patient outcomes.
- Comply with Austin Health documentation requirements, data collection and other administrative systems.

Selection criteria

Essential Knowledge and skills:

- Minimum 5 years' experience in the provision of therapeutic massage, including three years

 setting.
- Demonstrated understanding of the special needs of people with cancer physical, psychological, emotional, spiritual, and informational
- Demonstrated competence in providing massage support to people of varied social, cultural, and religious backgrounds.
- Demonstrated competence in implementing and maintaining self-care routines.
- Ability to work effectively in a team environment as a member of a multi-disciplinary team.
- Excellent communication and interpersonal skills both face to face and telephone
- Computer skills to enable accurate scheduling, documentation in electronic medical records, recording of appropriate data and preparation of written material for patients and staff.

Desirable but not essential:

- A sound understanding of information technology including clinical systems.
- Demonstration of relevant recent professional development activities

Professional qualifications and registration requirements

- Relevant qualification: e.g., Completed Diploma of Remedial Massage, Advanced Diploma of Myotherapy, Bachelor's degree in Osteopathy
- Completion of Modules 1, 2, and the Advanced Program (previously OM3 and 4) in Oncology
 Massage Training through Oncology Massage Training
 (www.oncologymassagetraining.com.au) or equivalent. Candidates who have not undertaken
 this training but have equivalent in expertise and experience working in an oncology setting
 will be considered.
