- Provide assessment and management of communication and swallowing difficulties to clients of the Brain Disorders Unit of Austin Health
- Perform the duties of this position efficiently to the standards of the Unit

## **About the Brain Disorders Unit**

The Mental Health Division provides care and services through a comprehensive range of teams to meet the needs of mental health consumers and carers throughout Victoria. Services are located across Austin Health campuses and in the community.

All mental health services work within a clinical framework that promotes recovery oriented practice and supported decision making. This approach to client wellbeing builds on the strengths of the individual working in partnership with their treating team. It encompasses the principles of self-determination and individualised treatment and care.

The Brain Disorder Unit is located on the Royal Talbot Rehabilitation Centre at Kew specialising in the management of individuals under the age of 65 years with a brain injury or neurodegenerative conditions and associated psychiatric disorders including behavioural disturbance.

#### The Brain Disorders Program (BDP) includes the following components:

- The Community Brain Disorder Assessment and Treatment Service (CBDATS), which provides assessment, short-term treatment and consultancy to consumers in the community. CBDATS is currently developing its teaching and research profile within the community nationally and internationally.
- The ABI Behaviour Consultancy, a community-based service that provides state-wide behaviour support to adults with an acquired brain injury. In addition to direct client based intervention, the service also offers secondary consultation, education and training to community disability services.
- The Neuropsychiatry Outpatient Clinic is a tertiary referral neuropsychiatry assessment service, based at the Heidelberg Repatriation Hospital.

#### **Brain Disorders Unit (BDU):**

- A 10-bed psychiatric rehabilitation unit (Heath Unit) specialising in medium term rehabilitation for appropriate consumers.
- A 20 bed extended care program (Wattle/Protea Units) which is a partly Commonwealth funded interim nursing home, specialising in the provision of a secure transitional environment for more disabled members of the target population.
- A 3 bed transitional housing facility (Step 2) as part of the community reintegration

## **Purpose and Accountabilities**

#### Clinical

- Provide assessment and management of clients in BDU with communication and swallowing disorders independently
- Assess and implement augmentative and alternative communication options to patients as appropriate
- Advise family and team members regarding the patient's communication/swallowing disorders, prognosis and management
- Participate in ward, team and family meetings as required
- Make appropriate recommendations/referrals for further management in the community
- Display a clear understanding of the principle of recovery orientated practice and its implementation within a clinical setting
- Provide input into discussions regarding goals and objectives for programs
- Abide by Austin Health corporate policies and practices as varied from time to time
- Perform other activities as requested by the Nurse Unit Manager BDU
- Contribute to the rehabilitation team's knowledge of each resident and their communication and swallowing function
- Maintain required clinical records via CERNER, SMR
- Ensure that all documentation is compliant with Expected Outcomes of the Aged
   Care Accreditation Standards

#### **Administration**

- Attend and participate in regular team meetings
- Advise the Nurse Unit Manager of appropriate equipment and resources required for client/ward use
- Participate in review and development of policy, goals/objectives and strategic direction of the BDU
- Perform other activities as requested by the Nurse Unit Manager

#### **Quality and Safety**

- Identify, develop and participate in Continuous Quality Improvement projects being run in the BDU and assist other staff in identifying areas for potential projects
- Actively participate in the ongoing identification, assessment, treatment and prevention of risks.

## Teaching, Training and Research

- Provide education and training to other health professionals, students and others both within the organisation and externally, where appropriate, on issues pertaining to Speech Pathology
- Provide clinical supervision of undergraduate and/or postgraduate Speech Pathology students as appropriate
- Participate in research programs run in the BDU as appropriate

## **Professional Development**

- Maintain a high standard of knowledge by participation and contribution in relevant professional development and research activities
- Participate in annual performance appraisal, supervision and Professional Development Planning process

#### Occupational Health and Safety

- Adhere to Occupational Health and Safety procedures including infection control within the BDU and Austin Health and practice these at all times with clients
- Actively participate in the ongoing identification, assessment, treatment and prevention of risks.

- Knowledge and experience in the assessment and management of dysphagic patients including referral indicators for videofluoroscopy
- Demonstrated flexibility in caseload management, in particular, an ability to manage a busy and varied caseload
- Effective written and oral presentation skills
- Ability to function effectively as a team member
- Strong organisational and time management skills
- Demonstrated commitment to implementation of evidence based practice
- Proactive approach to problem solving and strong analytical and conceptual ability
- Previous clinical supervision experience with undergraduate/postgraduate students
- A commitment to Austin Health values

- Demonstrated experience in quality initiatives and clinical research
- Further education in a relevant clinical field
- Knowledge of information technology and software applications
- Demonstrated evidence of professional initiatives over the past twelve months
