Position Purpose

This role is responsible for the design, maintenance and testing of data warehouse reporting solutions managed by the Austin Business Intelligence Unit. The role will develop, and work with existing, business requirements from a data warehouse project to ensure the design of the data warehouse meets the business needs.

Engage and collaborate with other key stakeholders to understand requirements. Proactively manage the overall design of the enterprise data warehouse and decommissioning of legacy data-warehouses.

The incumbent will need a deep understanding of

- Enterprise data-warehousing
- Kimball Dimensional Modeling.
- Building data models to address reporting requirements.
- Ingesting data from hospital systems in to staging and persistent staging layers to address reporting/ data requirements of new function.
- Ensuring CEDW (clinical enterprise data warehouse)/ reporting and presentation layers are ready for consumption by BI Reporting Tool like Power BI and self-service ready.
- Designing, building and documenting enterprise data models with a view of building single versions of the truth across multiple clinical and nonclinical areas
- Evolving the CEDW (clinical enterprise data warehouse) in a best practice approach to reflect the changing reporting environment.

About Business Intelligence

The Business Intelligence Unit is responsible for three key areas:

- Data Warehouse management
- Clinical and performance reporting
- Analytical projects

Two reporting teams cover all analytical and reporting services for Austin Health in relation to clinical operations, funding and performance; and assistance with

research analytics. The Data Services team are responsible for the Austin Health data warehouses and provision of data to the organization.

Position Accountabilities

Role Specific:

- Develop and enhance the Austin Health Clinical Enterprise Datawarehouse by adding more data sets to address reporting requirements from various clinical areas.
- Identification and implementation of improvements to the Austin's Clinical Enterprise Datawarehouse.
- Oversight of data quality and escalated issues that impact the operations of the hospital.
- Proactively monitor and maintain the relevant data warehouse environments and resolve all processing issues.
- Play an active role in migrating current on-premise solutions to the Azure environment.
- Follow all documentation processes eg Jira, Confluence, GIT, data catalogue
- Ensure quality control of all developed artefacts for the Clinical Enterprise Data Warehouse.

Collaboration

- Develop a collaborative and trusted relationship with directors, managers, clinical staff and administrative staff across the organisation;
- Input to data and reporting groups/forums across the organisation;
- Attendance and active input to meetings, working groups, steering committees and improvement programs as required;
- Liaise with the Austin IT department;
- Ensure knowledge sharing is embedded and actively performed amongst data team and broader clinical analysts group.

- Attend to ad hoc data, reporting & analytical requests;
