#### **Position purpose**

Perform the duties of the position efficiently, according to the standards of the Unit including participating in the Austin Health performance appraisal program. Duties will include assessment of elective and emergency cardiothoracic surgery patients, participating in operating sessions and conducting ward rounds. Preparation and presentation of cases in clinical meetings including weekly audit, supervision and teaching of resident staff and administrative duties related to routine clinical duties.

The Director of Brian F. Buxton Cardiac and Thoracic Aortic Surgery Unit and the Director of Thoracic Surgery, within the general scope of the terms of the appointment, may allocate specific duties. Every endeavor will be made to ensure that such duties are allocated on a fair and equitable basis.

## About the Directorate/Division/Departments

#### BRIAN F. BUXTON CARDIAC AND THORACIC AORTIC SURGERY UNIT:

The Brian F. Buxton Cardiac and Thoracic Aortic Surgery Unit, as part of SAPM (Surgery, Anesthesia and Procedural Medicine), is responsible for the provision of services within the specialty to patients across Austin Health. The Director of the Department is A/Prof Siven Seevanayagam. A/Prof George Matalanis is responsible for the comprehensive Thoracic Aortic Surgery Program and is acknowledged as a world-renowned authority in all facets of thoracic aortic surgery.

The unit provides a sophisticated multi-disciplinary aortic surgery management meeting with participation of vascular surgeons and interventional radiologists. Opportunities exist for participation in endovascular procedures.

The Brian F. Buxton Cardiac and Thoracic Aortic Surgery Unit performs all types of adult cardiac surgery procedures, including complex valve repair procedures and management of tumours involving the heart.

Located at the Austin Hospital Campus, the Unit is committed to the provision of high-quality patient care and maintains an ongoing commitment to Undergraduate and Post Graduate teaching. Extensive unit based and collaborative research projects are undertaken within the department as well as part of multi-centre research initiatives. Also provided is a consultative service for other Units within Austin Health.

#### THORACIC SURGERY DEPARTMENT:

The Thoracic Surgery Unit, as part of SAPM (Surgery, Anesthesia and Procedural Medicine), is responsible for the provision of services within the specialty to patients across Austin Health.

Located at the Austin site, the Unit is committed to the provision of high quality patient care and maintains an ongoing commitment to Undergraduate and Post Graduate teaching. Also provided is a consultative service for other Units within Austin Health. Basic and Clinical Research is encouraged.

The unit provides a full range of thoracic surgical services with the exception of lung transplant services. Specialized areas of interest are laser bronchoscopy and oesophagoscopy and stenting of the tracheo-bronchial oesophageal systems. New opportunities to participate in the operating sessions at the Northern Hospital is currently being developed. The Director of Thoracic Surgery is Mr Simon Knight.

#### Position responsibilities

#### **Role Specific:**

- Provide comprehensive management of in-patients.
- Attendance at multiple weekly outpatient clinics.
- Attention to detail and set expectations and ensure exact clinical handover and continuity of care amongst team members.
- Participate in operating theatre duties within approved scope of practice.
- Participate in Unit meetings and activities.









- Seek guidance from Senior Fellows / Trainee Registrars and Consultants as required.
- Help prioritise the surgical waiting list equitably.
- Provide an on-call service as required.
- Provide a consultative service to other Units as required.
- Demonstrate a commitment to working as a team member with peer medical, nursing and other staff to provide efficient, safe and quality care across the continuum.
- Participate in the auditing and review of clinical practices to improve clinical outcomes.
- Attendance at Division of Surgery audit is compulsory and attendance at Surgical Grand Rounds is expected.
