Position purpose

Perform the duties of the position efficiently, according to the standards of the Unit including participating in the Austin Health performance appraisal program.

About the Department

The Vascular Surgery Unit, as part of the Surgery, Anaesthesia & Procedural Medicine Division, is responsible for the provision of services within the specialty to patients across Austin Health.

Located primarily at the Austin Hospital, the Unit is committed to the provision of high-quality patient care and maintains an ongoing commitment to Undergraduate and Post Graduate teaching. Also provided is a consultative service for other Units within Austin Health. The outpatient clinic runs weekly at the Heidelberg Repatriation Hospital campus of Austin Health.

Ward 6 West is the neurosurgery and vascular surgery ward located on level 6 of the Austin Tower. There is also a comprehensive vascular laboratory co-located on level 6.

Position responsibilities

Role Specific:

- Participate in the ANZSVS AVA auditing and review of clinical practices to improve clinical outcomes.
- Attendance at the Austin Hospital Division of Surgery weekly audit is compulsory and attendance at Surgical Grand Rounds is expected.
- Manage the surgical waiting list equitably.
- Supervise accredited surgical trainees and junior medical staff.
- Provide comprehensive management of inpatients and outpatients.
- Participate in Unit meetings and activities.
- Provide an on-call service as required.
- Provide a consultative service to other Units as required.
- Supervise trainees and junior medical staff.
- To assist the Director in administrative duties as required including the development and review
 of policies and procedures for the provision of services, updating as needed to reflect best practice
 and evidence-based medicine.
- To assist in the evaluation of the delivery of services and in implementing appropriate quality and risk management initiatives.
- Demonstrate a commitment to working as a team member with peer medical, junior medical, nursing and other clinical staff to provide efficient, safe and quality care across the continuum.

Teaching, Training and Research:

- Contribute to the supervision, education and training of junior medical, nursing and other clinical staff, including participating in their performance appraisal and feedback processes.
- Participate in both undergraduate and postgraduate teaching activities.
- Commitment to facilitate, conduct and participate in clinical and/or basic research.
- Participate in the auditing and review of clinical practices to improve clinical outcomes.

Credentialing and Scope of Clinical Practice

Core Scope of Clinical Practice – Procedures, therapies and competencies that a Fellow from the respective specialist medical college would be competent in practicing. This only applies to practice at Austin Health and its campuses.

- 1. A comprehensive understanding of the relevant pathophysiology of vascular surgical conditions, diagnostic skills, investigation modalities and management strategies
- 2. Appropriate ordering, conduct and interpretation of key vascular investigations
- 3. Pre- and post-operative management of all patients requiring vascular procedures including those in the critical care setting
- 4. Emergency and elective open and endovascular procedures for aortic aneurysm, dissection and related pathologies (including abdominal and thoracic disorders)
- 5. Acute and chronic visceral vascular conditions (including mesenteric and renal endarterectomy, bypass, thrombectomy and basic endovascular procedures
- 6. Open revascularization procedures for occlusive and aneurysmal peripheral arterial disease, including aorto-iliac, intralingual and infrapopliteal bypass, extra-anatomic bypass, thrombectomy and endarterectomy
- 7. Endovascular procedures for occlusive peripheral arterial disease, including diagnostic and interventional angiography, aorto-iliac and intralingual angioplasty and stenting
- 8. Extra-cranial cervical arterial procedures including endarterectomy, bypass and reconstruction for trauma or carotid body tumour resection
- 9. Procedures for limb salvage including emergency revascularization, fasciotomy and major amputation
- 10. Wound management of ulceration, infection and diabetic foot disease including wound debridement, minor amputation and split skin grafting
- 11. Vascular access procedures, autogenous and prosthetic access for haemodialysis and revision procedures, including insertion and implantation of central venous access devices
- 12. Venous procedures including open varicose vein surgery and management of chronic venous disease
- 13. Emergency management of vascular trauma
- 14. Elective and emergency exposure of major vessels for adjunctive surgery
- 15. Skill in the use of non-invasive diagnostic and interventional applications of ultrasound in vascular disease

This will be assumed if the Vascular Surgeon has a Fellowship of Royal Australasian College of Surgeons in Vascular Surgery or equivalent and an ongoing continuous Vascular Surgery practice.

Extended Scope of Clinical Practice – Procedures, therapies and competencies that a Fellow from the respective specialist medical college would be competent in practicing after additional training, qualifications and experience as determined by the Head of Unit* has been completed. This only applies to practice at Austin Health and its campuses.

*The Head of Unit is expected to apply guidelines from the respective specialist medical college and appropriate state, national and international guidelines.

- 1. Endovascular Surgery
- 2. Endovascular procedures of Infrageniculate Popliteal and Crural Arteries
- 3. Endovascular Thrombolysis, chemo-thrombolysis, mechanical thrombectomy procedures









- 4. Carotid/Vertebral Angioplasty/ stent
- 5. Renal Angioplasty/ stent
- 6. Renal transplantation surgery
- 7. Endovenous ablation of Varicose Veins
- 8. Hybrid repair to thoraco-abdominal aortic aneurysm and Type B Thoracic Dissection
- 9. Laparoscopic/Robotic assisted vascular procedures
- 10. Complex open, endovascular or hybrid thoraco-abdominal aortic repair
- 11. Thoracic outlet decompression
- 12. Thoracoscopic Sympathectomy

For general accreditation the following need to be satisfied

- Demonstrated continuing professional development
- Regular attendance at audit
- · Participation in one or more of the following
 - o Teaching or research
 - Organising audit
 - Clinical governance
 - Other role within Austin Health but outside of the unit/specialty
 - o College role.

For each area where special expertise needs to be demonstrated

Some or all of the following criteria will be used to assess accreditation:

- Specialist training or a specific fellowship
- Significant accumulated total experience in the field
- Recent experience (adequate number of cases per year in previous years)
- Satisfactory completion of an acceptable outside organisations credentialing requirements.

Selection criteria

Essential skills and experience:

- A commitment to Austin Health values.
- Must be a registered Medical Practitioner in Australia with the Australian Health Practitioner Regulation Agency (AHPRA).
- Current Fellowship of the Royal Australasian College of Surgeons or equivalent.
- Membership of the Australian and New Zealand Society of Vascular Surgery.
- Have appropriate training and experience applicable to the field of vascular surgery including vascular interventional procedures.









- Holder of current Radiation License, Department of Human Services (Radiation Act 2005).
- Demonstrated commitment to high quality patient care.
- Demonstrated commitment and ongoing activity in research and/or clinical audit activities.
- Involvement in teaching and training of medical, technical and nursing staff, including at undergraduate and post-graduate level.
- Attendance and active involvement in relevant departmental, organisational and external meetings (i.e. College, Association and National/International bodies).
- Demonstrates engagement, teamwork and collaboration.
- Have demonstrated ability to communicate effectively at all levels.
- Have demonstrated understanding of, and commitment to Clinical Governance.

Desirable but not essential:

- A sound understanding of information technology including clinical systems.
- Certificate of Participation in Binational ANZSVS Australasian Vascular Audit.
