### **Position Purpose**

- To safely and effectively provide physiotherapy intervention to acute and subacute rehabilitation patients.
- To work flexibly across the organisation in a senior rotational position
- To provide supervision to undergraduate physiotherapy students and associated programs.
- To develop and maintain clinical expertise in physiotherapy
- To actively participate within the relevant stream with operational requirements, planning, quality improvement, co-ordination and staff performance/development
- To be committed to ongoing learning and professional development

## **About Physiotherapy Department**

The Physiotherapy Department comprises about 92 EFT staff at the Austin Hospital, Heidelberg Repatriation Hospital and the Royal Talbot Rehabilitation Centre. It provides seven days per week, 12 hours per day services to acute and aged care areas. There is also a seven day a week primary care service for soft tissue injuries in the Emergency Department.

Our department is focused on providing high quality evidence-based care to all patients and clinical research is a priority of the department. Austin Health is a major clinical school for the University of Melbourne with responsibility for about 180 students from 1st through to 3rd year for the Doctorate of Physiotherapy (DPT) course. In addition, the department is also a major clinical school for Swinburne University.

The Grade 2 Physiotherapist employed into this position will work in a rotational capacity, consisting of 6-month rotations across the acute and subacute rehabilitation streams on all three Austin Health campuses. This position provides the opportunity to gain senior clinical experience in the Early Rehabilitation, Acute neurology, Acquired Brain injury, Better@Home and neuro-geriatrics teams. The Grade 2 Physiotherapist will work closely with the multidisciplinary teams to provide evidence-based intervention and gain skills in complex discharge planning, whilst developing a broad physiotherapy skillset which will support future career speciality.

#### **Purpose and Accountabilities**

## Role Specific Patient Care:

- Provide a high standard of patient-centred and evidence-based physiotherapy care to rehabilitation patients across Austin Health in acute and subacute inpatient wards
- Provide home-based intervention as required via Better@Home (inpatient bedsubstitution) program
- Facilitate safe and effective discharge planning and follow-up services when required
- Manage patients according to Austin Health protocols where relevant
- Appropriately document and provide detailed clinical handover of patient management
- Communicate/liaise with clients, family or caregivers and other members of the multidisciplinary team regarding patient progress/issues
- Coordinate and provide carer training to staff, family members or private carers as required
- Actively participate in team meetings, case conferences, family meetings and goal setting meetings to facilitate discharge planning
- Act as resource and consultant for physiotherapists, nursing, allied health and medical staff as required to facilitate clinical reasoning and discharge planning

#### Administration/Management:

- Maintain accurate clinical documentation / statistics as directed.
- Assist in reviewing and updating physiotherapy clinical resources as required.
- To conduct site and physiotherapy department activities as required.

#### Training and Development:

- Complete annual mandatory training requirements as specified by Austin Health.
- Maintain a current knowledge of relevant physiotherapy literature and clinical developments.
- Participate in other internal / external continuing education activities as appropriate e.g. APA special interest group activities, hospital lectures and courses.
- Participate in Department and/or ward-based quality assurance activities
- Participate in regular supervision with the Grade 3 senior clinician
- Provide formal supervision to Grade 1 physiotherapist and/or allied health assistants

 Promote team discussion about clinical reasoning and decision-making around indication for therapy and type of therapy required

#### Staff/Student supervision:

- Contribute to the orientation and supervision of rotating Physiotherapists, allied health assistants
- Supervise Swinburne student placements and University of Melbourne students as required

#### **Quality Assurance:**

- Assist in developing and maintaining guidelines and resources relevant to hospital accreditation and the National Standards for Safety and Quality in Healthcare.
- Actively participate in department and sub-department quality improvement activities as appropriate
- Support colleagues in the PT department and multidisciplinary teams to undertake quality improvement activities
