Position purpose

This position is designed to provide cover for Senior Physiotherapy roles within the department across all campuses and in the "at home programmes." Where significant leave is taken this Clinical role will step in and provide and support patient care by helping supervise and support junior staff and maintain the Clinical Staff Profile of the area.

About the Department

The Physiotherapy Department comprises approximately 112 EFT staff at the Austin Hospital, Heidelberg Repatriation Hospital and the Royal Talbot Rehabilitation Centre.

Clinical

A physiotherapy clinical service is provided seven days per week, 12 hours per day to acute and aged care inpatient areas as well as outpatient and community services. There is a seven-day primary care service for soft tissue injuries in the Emergency Department.

Education Partnerships

The Physiotherapy Department is a major clinical school for the University of Melbourne with responsibility for approximately 100 students across the three years for the Doctor of Physiotherapy graduate degree. The Physiotherapy Department also supports two industry partnership education roles with Swinburne University of Technology in Acute Physiotherapy and Neurology and is responsible for 50 student placements for the Swinburne University of Technology Master of Physiotherapy graduate degree.

Research

Clinical research is a priority of the department, supported by the University of Melbourne Chair of Physiotherapy at Austin Health.

Position responsibilities

- Grade 3 Physiotherapist Leave Cover Responsibilities
- Provide short-term or extended clinical cover for senior staff during periods of planned or unplanned leave.
- Support areas of highest clinical need, ensuring service continuity and maintenance of high-quality patient care.
- Areas of cover will be allocated based on the applicant's clinical experience and expertise.
- May include rotations across a range of inpatient units (medical, surgical, orthopaedics, neurosciences, etc.) and the Better at Home service.
- Collaborate effectively with multidisciplinary teams to maintain safe, efficient, and patient-centred care.
- Demonstrate flexibility, sound clinical reasoning, and leadership in managing varying caseloads and supporting junior staff when required.

- Provide wholistic patient care across a broad range of services in the acute or subacute or outpatient settings
- Be accountable for the clinical competency of early career physiotherapists / supervisees / physiotherapy students
- Ensure connection to and credibility with clinical staff on site and gain an understanding of the challenges and opportunities for clinical educative initiatives for each site
- Contribute to graduate entry curriculum development with our university partners in line with contemporary clinical practice
- Identify emerging and important questions in health professionals' clinical education
