### Position purpose

The role of the Senior Clinician is to support the person, their carers and family in identifying and building protective factors that reduce the risk of death by suicide. This is an interesting and varied position offering a unique opportunity to utilise your specialist therapeutic and risk assessment skills to support consumers with complex mental health and psychosocial stressors.

Additionally, there is an opportunity to facilitate or be part of groups with our consumers that focuses on sensory modulation strategies, building internal resilience, distress tolerance and therapeutic coping strategies. The senior mental health clinician will also network with stakeholders and carers and participate in quality improvement activities.

### About the Directorate/Division/Department

The Mental Health Division provides care and services through a comprehensive range of teams to meet the needs of mental health consumers and carers throughout Victoria. Services are across

Austin Health campuses and in the community. The Mental Health Division incorporates three program areas:

- Adult and Older Adult Mental Health Services
- Child and Youth Mental Health Services and,
- Mental Health Specialty Services.

All mental health services work within a clinical framework that promotes recovery-oriented practice and supported decision making. This approach to client wellbeing builds on the strengths of the individual working in partnership with their treating team. It encompasses the principles of self-determination and individualised treatment and care.

The Hospital Outreach Post suicide attempt Engagement (HOPE) Program provides support for people identified as at-risk of suicide who do not require Tertiary Mental Health services.

The aim of the program is to prevent avoidable suicide attempts and death by suicide by providing the target cohort with assertive, tailored post-vention and psychosocial support in the community for a period of up to three months. The program also supports the person's carers and families to identify and build the protective factors that reduce the risk of suicide attempt/completed suicide

The HOPE Team is a multidisciplinary team that consists of Consultant Psychiatrist, Senior Mental Health Clinicians, Psychosocial Support Workers, Family Therapist and Lived Experienced Workers. The HOPE Team provides tailored, holistic support to people post suicide attempt or people with ongoing suicidal ideation.

## Position responsibilities

- The Senior Clinicians will work collaboratively with the HOPE Manager to meet the objectives as determined by the DHHS and the Austin Health Mental Health Division management team.
- The Incumbent will utilise knowledge and skills to provide counselling to consumers who have mental health issues.
- The HOPE Senior Clinicians will develop effective relationships with key stakeholders internally as well as with organisations in the community.
- Apply sound clinical knowledge and an in-depth understanding of contemporary mental health practices to ensure quality clinical outcomes are achieved.
- With the support of the HOPE Manager and HOPE Consultant, provide day to day clinical shift leadership.
- Implement, monitor and review therapeutic and psychosocial case management plans in collaboration with the Psychosocial Officers to ensure positive outcomes for the consumer group.
- Independently conduct assessment of mental state and risk and work with other stakeholders or acute services to develop appropriate management plans for consumers who present in crisis, with ability to transfer clinical care to appropriate tertiary services where necessary.
- Mentor HOPE Psychosocial Officers in line with professional qualification.
- Display a clear understanding of the principle of recovery orientated practice and its implementation within a clinical setting.
- Engage/maintain relationships with internal Austin Health stakeholders.
- When on shift, participates in clinical review processes, and clinical data collection.
- Develop, implement and evaluate continuous quality improvement activities within the quality assurance framework and actively manage accreditation requirements.
- Demonstrate a commitment to professional development.
- Demonstrate a commitment to own clinical supervision.
- The Senior Clinician positions will be supported by the HOPE Manager, the Divisional Manager AOAMHS and the discipline specific Allied Health Chief.

## Selection criteria

### Essential skills and experience:

- Clinical expertise in mental health and risk assessment, diagnosis and treatment in line with scope of practice of qualification
- Clinical expertise in delivery of a range of short-medium term therapeutic, evidence based interventions in line with relevant qualifications and scope of practice. Ability to deliver best practice brief therapeutic interventions designed to increase the ability to self-manage and prevent the risk of future suicide attempts
- Demonstrated clinical experience in the Area Mental Health Service
- Sound understanding of best evidence base surrounding suicide prevention
- Thorough knowledge of the principles and practices of DHHS Recovery-Oriented Practice in Mental Health
- Experience in case management of consumers with a wide range or psychosocial needs to improve their level of functioning via implementation of tailored individualised, treatment plans.
- Demonstrated commitment to care of consumers and their families in the least restrictive and intrusive manner, respecting rights, privacy and dignity.
- Sound knowledge of The Victorian Mental Health and Wellbeing Act (2022) and other relevant legislation
- Highly developed communication skills to effectively support a wide range of staff.
- A current Victorian Driver's License and ability to drive a work vehicle.

### Desirable but not essential:

- Ability to coordinate and facilitate group sessions with the consumers of the HOPE Team that focuses on skills training, with particular emphasis on distress tolerance, mindfulness and therapeutic coping strategies
- Dual diagnosis experience
- Demonstrated experience in the Duty Role in a AMHS program
- Demonstrated experience in the provision of clinical/professional supervision or willingness to develop these skills
- Evidence of on-going professional development
- Demonstrated capacity to undertake/support research, publication and public presentation.

## Professional qualifications and registration requirements

- Registration with AHPRA as a Registered Nurse with a Post Graduate Diploma in psychiatric/mental health nursing or to have completed a specialist undergraduate psychiatric nursing program; or
- An approved degree in Psychology and registration with AHPRA as a Psychologist with endorsement as a Clinical Psychologist; or
- An approved degree in Occupational Therapy and registration with AHPRA as an Occupational Therapist; or
- An approved degree in Social Work and eligibility for membership of the Australian Association of Social Workers;
- Must meet minimum years of clinical experience for a mental health clinician role (for the profession according to the relevant Enterprise Agreement);
