## **Position purpose**

The Grade 3 Orthoptist is a senior clinical leader and subject matter expert, responsible for delivering high-quality, evidence-based orthoptic care across Austin Health. This role integrates expert clinical practice with leadership, education, research, and service development to ensure optimal patient outcomes and continuous service improvement.

With at least seven years of professional experience and recognised specialist knowledge, the Grade 3 Orthoptist is expected to exercise advanced professional judgement, work autonomously in clinical decision-making, and contribute to the strategic and operational planning of the Ophthalmology Unit. The role includes mentoring and supervising junior orthoptic staff and students, contributing to clinical audits (including biometry and cataract surgery outcomes), and fostering strong relationships with key stakeholders such as La Trobe University and Orthoptics Australia.

Working in close collaboration with the Head of Department, the Grade 3 Orthoptist supports service leadership by promoting best practice standards, advancing innovation through research and teaching, and ensuring clinical governance and quality assurance within the orthoptic service.

## About the Directorate/Division/Department

The Ophthalmology Unit is based in the Outpatients Department at the Repat Campus, where multiple clinics run throughout the week.

The Orthoptic Unit, closely integrated with the Ophthalmology Unit, delivers comprehensive orthoptic services across Austin Health. Both inpatient and outpatient orthoptic services are based at the Repat Campus and the Royal Talbot Campus. The unit is dedicated to providing high-quality patient care and has a strong commitment to undergraduate and postgraduate teaching.

Both the Ophthalmology and Orthoptic Units operate within the Surgical and Procedural Medicine (SAPM) Division, which offers a broad range of surgical services, including elective and 24/7 emergency surgery. The division is committed to delivering exceptional patient care and fostering ongoing professional development for its staff.

## Leadership & Strategic Support

- Provide expert clinical leadership in designated orthoptic-led clinics, supporting the Chief Orthoptist in driving service excellence across Austin Health.
- Support the implementation of service improvement initiatives and caseload prioritisation strategies to enhance responsiveness and safety of clinical services.
- Collaborate with the Chief Orthoptist and Head of Ophthalmology in strategic planning and service development.

## Clinical Excellence & Quality Improvement

- Deliver high-quality, evidence-based orthoptic care with advanced clinical decisionmaking in areas such as cataract, glaucoma, neuro-ophthalmology, and retinal disease.
- Work collaboratively with orthoptists, ophthalmologists, nursing staff, and registrars to ensure efficient multidisciplinary clinics and optimal patient flow.









- Contribute to the development, implementation, and evaluation of clinical protocols and care pathways in collaboration with the Chief Orthoptist and senior medical staff.
- Assist in the auditing of clinical outcomes (e.g., cataract surgery results, biometry accuracy) to inform quality improvement.

## Workforce Development & Professional Leadership

- Provide professional supervision, guidance, and support to Grade 1 and 2 orthoptists.
- Contribute to onboarding, peer mentoring, and competency development of new staff under the direction of the Chief Orthoptist.
- Promote a positive team culture and collaborative working environment aligned with Austin Health values.

#### **Education & Research**

- Lead and contribute to the clinical teaching of undergraduate orthoptic students in partnership with La Trobe University and in alignment with the department's teaching program.
- Support and participate in the teaching of ophthalmology registrars and medical students, fostering an interprofessional learning environment.
- Actively engage in clinical research and support the Chief Orthoptist in facilitating and promoting research activity within the unit.
- Participate in internal and external professional development events and demonstrate a commitment to continuing professional growth, including presenting at conferences and professional forums.

## **Operational & Administrative Support**

- Support the Chief Orthoptist in optimising clinic workflow and patient scheduling, ensuring high-quality and timely care delivery.
- Provide input into service planning, rostering, and resource utilisation as required.
- Participate in departmental meetings, clinical governance activities, and Austin Health's performance development program.
- Attend Royal Talbot Rehabilitation Centre as required to deliver orthoptic assessments for ABI, Mellor, and Spinal patients.
- Undertake administrative tasks including documentation, reporting, and stock/equipment liaison in support of the service.

- Minimum of seven (7) years of clinical experience in orthoptics, with demonstrated expertise across a broad scope of practice.
- Proven ability to work independently and exercise expert professional judgement in orthoptic-led clinics.
- Commitment to delivering high-quality, evidence-based, patient-centred care.
- Strong understanding of professional, legal, and ethical standards in orthoptic practice.
- Demonstrated commitment to continuous quality improvement, patient safety, and clinical governance.
- Experience supporting service improvement initiatives and implementing change within a multidisciplinary team environment.
- Demonstrated experience in mentoring and supporting the development of junior orthoptists and students.
- Active involvement in undergraduate and postgraduate teaching of orthoptic and medical students.
- Capacity to contribute to research and educational programs in collaboration with the wider ophthalmology team.
- Highly developed interpersonal and communication skills, with the ability to engage effectively with colleagues, students, patients, and stakeholders.
- Proven ability to work collaboratively within a multidisciplinary team to provide coordinated, high-quality care.
- Proficient in the use of clinical information systems and electronic health records.
- Experience with rostering systems and risk management reporting tools.
- Advanced computer literacy, including Microsoft Office Suite (Word, Excel, Outlook, PowerPoint).
- A commitment to Austin Health values, ensuring professional integrity and excellence in patient care.
